# A Matter of Perspective in Giving Thanks

Often in Special Education, questions arise which you may need the answer to and others may benefit from that answer as well. Each month we will include a few of these questions, so please don't hesitate to ask.

#### FREQUENTLY (RECENTLY) ASKED QUESTIONS

Q: Can we refuse an initial evaluation when a parent requests it if we see no educational impact?

A: Yes, we actually can under certain circumstances, but we need to be very careful about these kinds of requests. If the parent has made a similar

request within the past calendar year, we do not have to grant the request unless we feel that it is appropriate due to a change in circumstances, but in certain cases, if a student has not been involved in interventions prior to the request, or if there doesn't appear to

be any educational impact and the school doesn't believe the student would meet the second prong of the criteria, the school may refuse. In either case, prior written notice must be given within 10 days of the request to document why the school is refusing.

Q: We had an IEP where we'll walk through them. the parents were notified several times of the meeting but never responded. We called, emailed and sent the notice but on the day of the meeting they never showed. Because the student was making great progress, we wanted to decrease services by 25%. We sent home the prior written notice but the parents never sent it back. Can we reduce the services without consent?

A: As always, this doesn't have a really straightforward answer, but in short, yes, just not right away. There are a number of ways this could be achieved, so

First of all, the Kansas regulations requires parental consent if there is a material change of services which is 25% or more, Because you are reducing by 25% exactly, consent is required. If you feel like the parents would refuse, you can always reduce by 24% if the team feels that is in the best interest of the child

However, there is a difference between refusal and ambivalence. If the parent is simply ambivalent, we could send the parent notice that they have 5 days to respond before we implement the changes

as recommended. If they fail to respond to that notice as well, we can begin to implement the IEP as changed. If they respond with refusal, we will have to resort to option A. This is an issue specific to our state, as federal regulations allow for changes to the IEP at the teams discretion without a signature required. Under federal regulations, a signature is only required to evaluate or for the initial provision of services. But as long as the Kansas regulations stipulate, consent for such a change is required prior to beginning services unless we notice parents as mentioned.

## Crisis Prevention Intervention Training and ESI

If you are currently certified in CPI, please make note of when your certification expires and take advantage of the recertification trainings that are available to you. Our next CPI refreshers will be held on December 12 from 11:30-3:30 and December 15 from 8:30

to 11:30, both at the West Resource Center in Eudora. Don't forget that if you let your certification expire, you may be required to take the full course over again, which is longer. Also remember that if you are in a program where ESIs are a likelihood, such as the

WEBS program or Life Skills, this certification is required, as state regulations around the use of emergency safety interventions prohibit you from engaging in a restraint or seclusion if you do not have current certification in CPI or another alternative.

Just a reminder that in order to provide the best foundation for your students' upcoming IEPs, the parent input form and teacher input form well in advance of the IEP meeting.
Because meaningful
parental participation is
required under IDEA,

provides us with documentation of that participation. Also, please don't forget to have a draft IEP prepared and sent out to parents 5 days prior to the meeting.
