With his departure we will likely transition from our CPI-Crisis Prevention Intervention training to

- SCM-Safe Crisis Management starting early in the summer. SCM is a better option with younger students for transport and carry.
- End of the year conferences should be completed by April 15th with the certified staff.
- The estimates for the budget are still in process, but are likely to be a bit higher than anticipated originally. The WEBS assessment will increase to reflect accuracy for accounting purposes.
- The staff was reminded of the Medicaid replacement funds reporting date window from February 22nd through March 7th and responded appropriately.
- Still awaiting the results on our budget audit appeal from KSDE on teacher reimbursement and transportation.
- Negotiations are anticipated to begin in April, but our letter will be delivered to the NEA by March 31st.
- Board Handbook and Interlocal Agreement revisions for review at the April meeting.
